Dear Parents/Guardians,

On **Monday, October 7<sup>th</sup> 2019, Mrs. Maynard** and on **Tuesday, October 8<sup>th</sup> 2019 Mrs. Carlson and Mrs. Going** will be taking their 7<sup>th</sup> grade science classes to the Sunken Forest at Sailors' Haven on Fire Island. The cost of the trip will be **\$40.00** per student to cover the cost of the bus and ferry ride to and from Fire Island.

We will **leave** Wisdom Lane at **8:15 a.m.** and will take the 9:30 ferry out of Sayville. We should be at Sailors' Haven by 10:00 a.m. We will return to Sayville on the 1:30 p.m. ferry and should **arrive** at Wisdom Lane approximately **3:00 p.m.** (*traffic permitting*).

Students should be prepared to be outside for the entire afternoon. Please have them dress for the weather, remembering that it is usually cooler at the beach than in Levittown. It is better to dress in layers; it is easier to take a sweater off if you get too warm. There is **no cafeteria** at Sailors' Haven, so students will need to **bring their own lunch**. There are restroom facilities in a few locations throughout our tour of the forest.

Student must have their money and permission slips to **Mrs. Going** no later than **Wednesday, September 25<sup>th</sup>**. Please make checks payable to Wisdom Lane Middle School.
